The above rates exclude the Wedding meal and all beverages.

Rates exclude the gate conservation entry fee which is payable per vehicle per stay.





WEDDING TERMS AND CONDITIONS

RESERVATIONS / ROOMING LIST

To confirm a wedding booking, a deposit equal to 10% of the total booking is to be paid within 21 days of the booking date.

Full pre-payment is required 61 days prior to arrival. A final list of all guests, indicating guest's initials and surnames and which persons are sharing is required in writing no later than 14 days prior to arrival.

All cancellations must be sent in writing to reservations.

In the event of the entire wedding been cancelled, a 50% cancellation penalty will be applicable on the accommodation and venue charges if cancelled 60 to 46 days prior to the event and a 100% penalty if cancelled 45 days or less prior to the event.

Should the wedding party numbers reduce prior to the event, the non-occupied rooms will be charged at 35% of the single occupancy rate.



PROGRAMME AND CATERING REQUIREMENTS

Catering requirements will be finalized in documentation following these agreements and will be considered as an addendum to this document.

Safari Plains requires a detailed program of events in writing no later than 21 days prior to arrival. Failure to supply us with this information timeously may result in the lodge being unable to finalize arrangements for your group adequately.

Special requirements should be communicated to Safari Plains timeously to ensure compliance.

The lodge will forward a copy of the final function sheet for approval prior to the arrival of the group.

Signing the function sheet and returning it to the lodge confirms your approval of arrangements.

Changes required may be indicated on the function sheet.

ALL MUSIC MUST BE TURNED DOWN AT 11PM and OFF AT 12PM.





Should the deposit and payment terms not be met on or before the due date (unless prior arrangements have been authorized by management) the hotel reserves the right to release all reservations held and free to sell to other clients. It is the sole responsibility of the client or booking agent to ensure payment are made on due date.

Should the reservation be made within 30 days prior to arrival a deposit equal to 50% of the total Fully Inclusive Package amount quoted will be due immediately, with the balance paid within 14 days prior to arrival.

The balance outstanding from services rendered to the client during the function held at the Lodge must be settled prior to departure.

Where the client has contracted a third party such as a PCO or Travel Agent, to reserve and/or co-ordinate the booking, the client remains the principal party within this agreement and shall remain responsible to the Lodge for settlement of any amounts due to the Lodge in terms of this agreement.

Should the client elect to settle the outstanding balance due to the Lodge via such a third party, the client remains responsible for such debt until it has been settled in full.

Payment must be made directly into the bank account of the Lodge and proof of payment must be sent to the Lodge. Any payment outstanding, not paid to the Lodge within 30 days after departure, will accrue interest at prime +1%.

CANCELLATIONS

Should a reservation be cancelled after the signing of this contract, cancellation charges will apply:

25%	90 - 61 days prior to arrival
30%	60 - 46 days prior to arrival
90%	45 - 31 days prior to arrival
100%	30 days or less prior to arrival

DIRECTIONS FROM OR TAMBO INTERNATIONAL AIRPORT:

Follow signs from Kempton Park / R21 / Pretoria and merge onto the R21. After 31.3km take exit 134 For N1 North towards Polokwane. Merge onto the N1 and travel 70.2km before taking exit 238 to Bela Bela and from there;

- Head northwest on R516 toward Khota St / 2.8km
- Turn right onto Marx St / R101 / 550m
- Turn left onto Potgieter Rd / 160m
- Turn right onto Richie Rd / 220m
- Turn left onto Voortrekker Rd / 800m
- At the roundabout take the 1st exit onto Rooiberg Rd / 230m
- Continue onto R516 / 33km
- Take the D2533 / 3.5km Safari Plains will be on your left
